The Town of Plymouth is seeking BIDS/PROPOSALS from qualified companies for:

**2023 Post Flood Paving Project**

Bid/Proposal should include materials, equipment, and labor to complete the following work:

- Provide and install construction signage (road closure) and traffic control.
- All roads must be cleaned, prepared, and have emulsion applied by contractor prior to placing mix.
- Bids must specify for each site the cost per ton laid in place.
- The anticipated project duration is four weeks and work must be completed no later than November 15, 2023.
