

## **Revised Notice of Public Hearing**

The **Town of Plymouth, Vermont** is considering making application to the State of Vermont for an {CDBG Disaster Recovery Implementation/ CDBG Disaster Recovery Planning} Grant under the Vermont Community Development Program. A public hearing will be held at 6:30 PM on Monday, September 8, 2025 at Town of Plymouth, Vermont Municipal Building located at 68 Town Office Road, Plymouth, Vermont 05056 to obtain the views of citizens on community development, to furnish information concerning the amount of funds available and the range of community development activities that may be undertaken under this program, the impact to any historic and archaeological resources that may be affected by the proposed project, and to give affected citizens the opportunity to examine the proposed statement of projected use of these funds. The **revised** proposal is to apply for **\$250,000.00** in CDBG-DR - Planning funds which will be used to accomplish the following activities:

**Money Brook** – Feasibility study to investigate stabilization of the hillside that saw landslides as a result of the July 2023 disaster events. The proposed Work Product(s) of the planning grant is to determine the best solution to stabilize and fix the mud slide, and the developing flood plain solutions to mitigate future disasters in the same area as outlined:

**Landslide & Alluvial Fan Activity – Needs Fixing  
Stabilization of Mud Slide / Bank  
Containment of Clay & Sediments  
Heavy Fabric Installation  
Clean & Possibly Widen Brook to Match Width of New Bridge on Route 100N in 2026  
Possibly Build Cofferdams or Sediment Ponds  
Environmental Review**
